

## *2019 Scholarship Award*

The **Mid-Jersey Chapter** of the **Hospitality Financial & Technology Professionals (HFTP)** has developed a scholarship program in an attempt to recognize students who have demonstrated a sincere desire to pursue a career in either accounting, business, finance, hospitality, or management information systems (MIS).

In 2019, the Mid-Jersey Chapter will award one scholarship in the amount of **\$1,000**, based on the merit of applications. The scholarship award will be made in accordance with the guidelines of the Selection Committee, and approved by the Board of Directors of the Mid-Jersey Chapter. The award will be presented at a function sponsored by the Mid-Jersey Chapter.

### Who is Eligible - all three criteria must be met

- 1 – Active Mid-Jersey Chapter members, their spouses, their children, and full-time employees of member properties.
- 2 – Acceptance in a degree program at an accredited college or university.
- 3 – Must have a concentration in the fields of accounting, business, finance, hospitality or MIS.

### Requirements

- Complete and submit an official application by **July 31** of the academic year.
- Attach a copy of your official college transcript or your current semester schedule to the application.
- Write an essay or personal statement ( not to exceed one page) addressing the following components;
  - your career objectives
  - what has motivated you to pursue a career in accounting, business, finance, hospitality, or MIS and why do you think you will succeed at it?
